Human Trafficking - Andrea Dalziel

Andrea Dalziel gave a **Power Point Presentation – attached.**

Andrea gave an overview of what is happening provincially and within the agency in terms of learning, training and recognizing and human trafficking within the work that we do. She reported we are doing well at adopting the recommendations that have been made provincially.

Andrea Dalziel introduced Taylor Dunlop from the House of Sophrosyne. Taylor gave a brief overview of the successful and beneficial partnership that we have with the House of Sophrosyne; it is funded by the Local Health Integration Network (LHIN). Numerous programs and service options are available for mothers and fathers in recovery.

Provincial Indigenous Strategies – Jennifer Thrasher

Jennifer Thrasher gave an update on the status of the commitments made following the provincial apology to Indigenous people. There is now focus on four strategies to make improvements locally and provincially. They are related to: identification; cultural plans; training; and Sixties Scoop Disclosure.

CYFSA Policy Changes - Jennifer Thrasher

The Children's Services and Resource Policies were reviewed by the Committee.



There were updates to policies as a result of the new legislation. A motion will be brought to the full Board for approval of the policy changes.

One policy for the Board's consideration is CS-62 – Assistance Post 21. We have provided emotional assistance for young people after they age out of care as well as the provincial After Care Benefits. There are at least 2 agencies who provide additional financial assistance post 21 especially related to education. Committee members agreed this was something for the full Board to consider. Preparation will be done so the Board has further information to consider at the Board meeting. The question will be whether or not the Board wants to provide additional assistance and if so, how.
